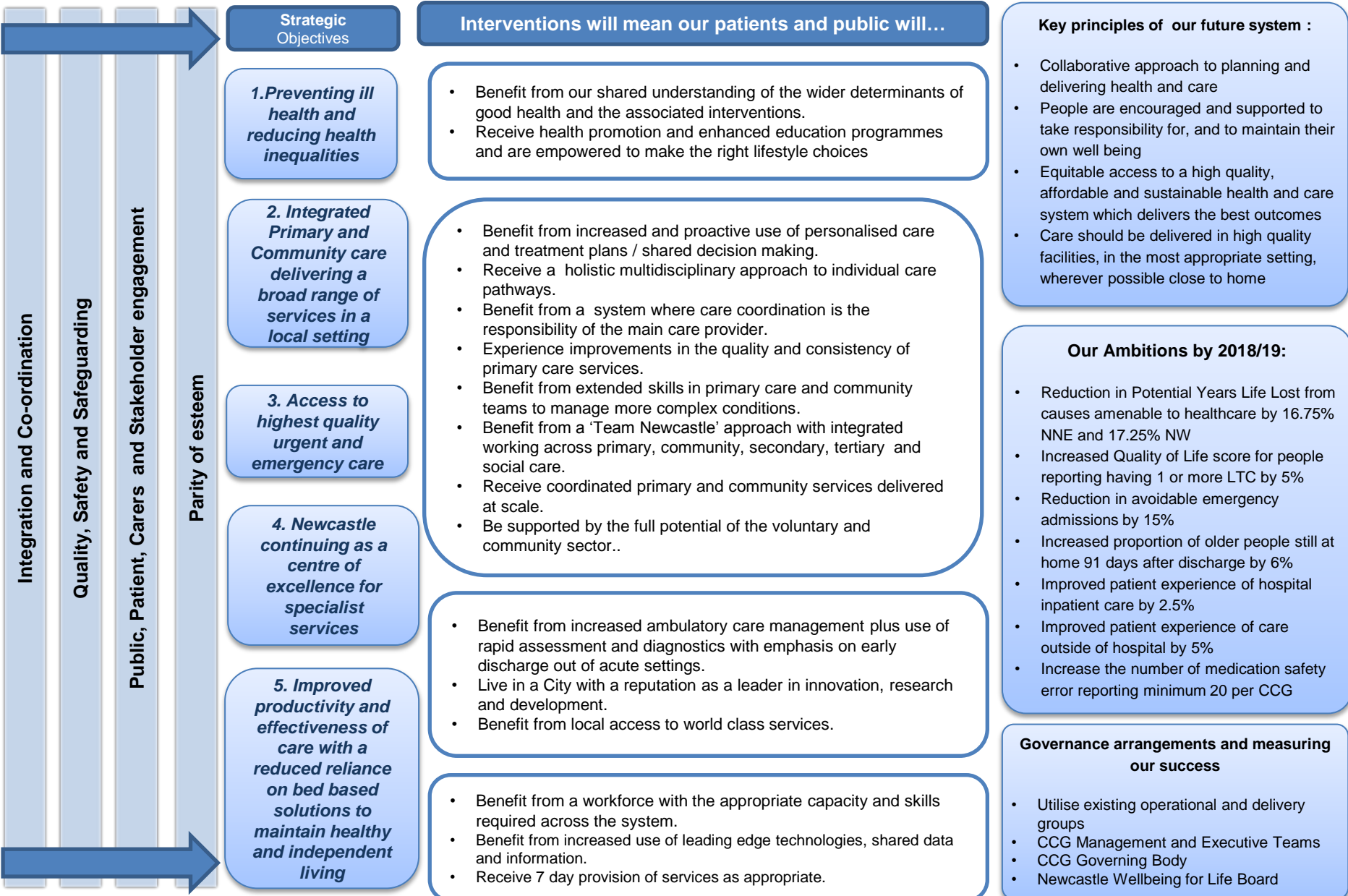


Newcastle health and social care partnership – moving towards 2018/19

- ### Key principles of our future system :
- Collaborative approach to planning and delivering health and care
 - People are encouraged and supported to take responsibility for, and to maintain their own well being
 - Equitable access to a high quality, affordable and sustainable health and care system which delivers the best outcomes
 - Care should be delivered in high quality facilities, in the most appropriate setting, wherever possible close to home

- ### Our Ambitions by 2018/19:
- Reduction in Potential Years Life Lost from causes amenable to healthcare by 16.75% NNE and 17.25% NW
 - Increased Quality of Life score for people reporting having 1 or more LTC by 5%
 - Reduction in avoidable emergency admissions by 15%
 - Increased proportion of older people still at home 91 days after discharge by 6%
 - Improved patient experience of hospital inpatient care by 2.5%
 - Improved patient experience of care outside of hospital by 5%
 - Increase the number of medication safety error reporting minimum 20 per CCG
